Trash & Recycling Fees to Increase

Everyone is feeling the pinch of increased fuel costs. It affects not only individuals but companies as well. As fuel costs escalate, so does the cost of every consumer product, from eggs and milk to appliances and automobiles. All of these products are delivered in vehicles using gasoline or diesel.

Trash hauling companies are greatly affected. Higher fuel costs have also resulted in a price increase in the new refuse and recycling contract that Lancaster Township entered into with Lebanon Farms Disposal, Inc. (LFD). As the current three-year contract neared its end on September 30, 2005, the Township advertised Requests for Proposals in an effort to obtain the best price on a new contract. Three companies submitted bids for the contract. The bid from LFD was the lowest. Still, residents' trash/recycle rates must be increased as of October 1, 2005 because of the new higher contract price. The new rate is \$165 per year per household. Since residents are billed every six months, the semi-annual bill will be in the amount of \$82.50. A senior discount of 10% is still available to those 60 years of age or older (proof of age required). With the senior discount, the fee is \$148.50 per year or \$74.25 for six months.

Even with the fee increase, Lancaster Township still has one of the lowest fees in the county. The Township will continue to provide biobags to residents free of charge. ■

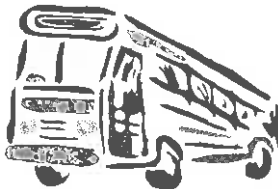

Large Appliance and Tire Collection

LARGE APPLIANCE AND TIRE PICKUP WILL BE HELD THE WEEK OF DECEMBER 5-8, 2005 ON YOUR REGULAR COLLECTION DAY: DECEMBER 5 (MONDAY), DECEMBER 6 (TUESDAY), DECEMBER 7 (WEDNESDAY), OR DECEMBER 8 (THURSDAY). THE TOWNSHIP OFFICE MUST BE NOTIFIED OF ANY ITEMS TO BE COLLECTED. A \$12 BLUE TAG MUST BE PURCHASED AND ATTACHED TO EACH APPLIANCE. A \$1.25 PURPLE TAG MUST BE PURCHASED AND ATTACHED TO EACH TIRE (NO RIMS). IF YOU ALREADY HAVE TAGS, PLEASE NOTIFY THE TOWNSHIP OFFICE OF THE ITEM(S) TO BE COLLECTED. WE PROVIDE A LIST TO THE HAULER WITH ADDRESSES AND ITEMS TO BE COLLECTED. A SEPARATE TRUCK WILL COLLECT THESE ITEMS AND MAY ARRIVE AT A DIFFERENT TIME THAN THE TRASH TRUCK. 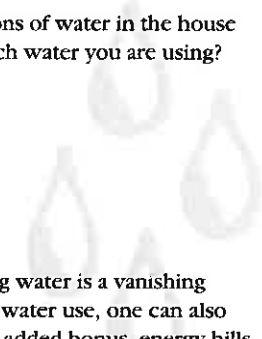
CONSERVE WATER!

The average American uses 60 gallons of water in the house every day! Do you know how much water you are using? Here are a few statistics:

- 💧 Kitchen faucet: 3-5 gallons a minute
- 💧 Shower: 5-10 gallons a minute
- 💧 Tub bath: 50 gallons, if full
- 💧 Toilet flushing: 5-7 gallons
- 💧 Dishwasher: 15-25 gallons
- 💧 Washing machine: 35 gallons

Why save water? Because clean drinking water is a vanishing resource. By consciously cutting down on water use, one can also save money on the water/sewer bill. As an added bonus, energy bills decrease as the amount of hot water used decreases.

Repair all leaking faucets and pipes. Don't let water run when preparing meals. Take more showers than baths and make them shorter showers. When purchasing water-using appliances, look for water-saving models. ■



Change in Christmas Tree Disposal

The Township will no longer provide collection of Christmas trees. There are, however, several other convenient ways to dispose of them.



- 1.** Trees may be dropped off at the Lancaster Township Maintenance Facility at 1357 Meadowcreek Lane, Monday-Friday, 7AM to 4PM. Trees are to be deposited just inside the gate at the posted location.
- 2.** Trees may be included with your regular trash in lieu of a trash container. If the tree exceeds the 3-container limit, a yellow extra service trash tag is required (available at Township office).
- 3.** Trees may be dropped off at Lancaster County Park behind the main offices at 1050 Rockford Road, December 26-January 20. They request a \$1 per tree donation. The trees are shredded for mulch, which is available free beginning January 1. Bring your own shovel and bags.

2005 Holiday Refuse Collection Schedule

- Thanksgiving Day, November 24** — Only the Thursday collection is affected and moved to Friday
- Week after Christmas Day, December 25** — No changes
- Week after New Year's Day, January 1** — No changes

Remember, the limit is three (3) bags or containers (32-gallon size, weighing less than 30 pounds each) per week, including holidays. Amounts over the three-bag/container limit must have a yellow extra service tag attached to each container. Plan ahead for extra trash by purchasing yellow extra service tags (\$6.25/5 tags) at the Township office. Tags can also be purchased by mail by sending a check in an amount to cover the order.

Please put out trash on the night before collection day and remove the empty containers as soon as possible after collection.

Yard Waste/Biobags

COLLECTION OF YARD WASTE (NOT GRASS CLIPPINGS) IN BIOBAGS WILL END THE WEEK OF OCTOBER 3. RESIDENTS MAY CONTINUE TO DROP OFF THE MATERIAL AT THE TOWNSHIP MAINTENANCE FACILITY, 1357 MEADOWCREEK LANE, BETWEEN 3:00PM TO 6:00PM (2:00 TO 5:00PM AFTER DAYLIGHT SAVINGS ENDS), MONDAY TO THURSDAY, THROUGH NOVEMBER 23. BE SURE TO HAVE ID SHOWING YOUR ADDRESS.

AFTER OCTOBER 6, YARD WASTE IS TO BE COMBINED WITH REGULAR TRASH AND BECOMES PART OF THE 3-CONTAINER LIMIT. REMEMBER, BRUSH AND STICKS (MAXIMUM 2-INCH DIAMETER) MUST BE TIED IN BUNDLES AND WEIGH NO MORE THAN 30 POUNDS.

New Use for Orange Battery Bags:

ALONG WITH REGULAR HOUSEHOLD BATTERIES, CELL PHONES MAY NOW BE PLACED IN BATTERY BAGS FOR PROPER DISPOSAL. WHEN THE BATTERY BAG IS FULL, PLACE IT NEXT TO THE TRASH CAN OR TRASH BAG (NOT IN IT). TRASH HAULERS WILL DROP THEM AT THE HOUSEHOLD HAZARDOUS WASTE FACILITY. BATTERY BAGS ARE AVAILABLE FOR FREE AT THE TOWNSHIP OFFICE.



DEPARTMENT REPORTS

Public Works: Ready for Leaves and Snow



Fall Leaf Pickup begins Monday, October 10 and ends Friday, December 9. Residents should rake leaves into the street as close as possible to the edge of the lawn or curb. Put leaves

out the day before a scheduled pickup. Because weather cannot be scheduled, rain or snow may prevent collection on the designated day. Please be patient; the Public Works crew will make its rounds as soon as possible.

It is important to eliminate any woody material, branches, and grass from the leaves. This material clogs the machinery and slows down the process.

2005 Leaf Collection Schedule

- ▶ **Monday:** All streets between Columbia Avenue and Marietta Avenue
- ▶ **Tuesday:** Hamilton Park area follows the posted street-cleaning schedule including the 400-500 blocks of Atkins Avenue, Spencer and South President Avenues, and Davis Drive; East End follows the Tuesday afternoon street-cleaning schedule and includes City Mill, Conestoga Woods area, and Conestoga Boulevard.
- ▶ **Wednesday:** Hamilton Park area follows morning street cleaning route and includes School House Road; East End follows afternoon street cleaning route.
- ▶ **Thursday:** All streets on the north side of Marietta Avenue to the south side of Newton Road
- ▶ **Friday:** West side of Abbeyville Road, Bausman area, Wedgewood area, Windolph Landing, Bentley Lane area, Honeysuckle Lane, and Millrace Drive

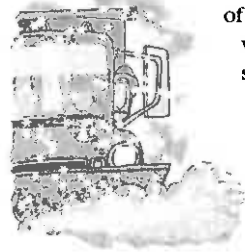
NOTE: Weekly pickup is not a guarantee. Weather conditions, leaf volumes, and other conditions beyond the Township's control will influence leaf pickup.

Woody Material Drop-Off is a very popular program and will continue through November 23. Woody materials from tree and shrub trimmings can be taken to our maintenance facility at 1357 Meadowcreek Lane between the hours of 3:00PM and 6:00PM (2:00 to 5:00PM after daylight savings ends), Monday through

Thursday. This effort is a major part of the Township's recycling program. The facility will reopen in April 2006.

Snow Plowing

Plowing begins when there is an accumulation of three inches on the roadways. Main roadways are plowed first, followed by the secondary roads. All roads receive two initial passes by the plow to allow for safe passage



of emergency vehicles. Do not shovel snow from your driveway entrance after the first pass. After opening all roads for emergency vehicles, the plow will return to widen roads (after snowfall stops). If you shovel before this second step, the driveway may have to be shoveled again.

It can be difficult for the snowplow operator to determine where a yard begins and the paved surface ends. Because of this, it is recommended that residents install stakes or flags at the edge of the property. Stakes may be installed as of November 1 and must be removed by April 1. ■

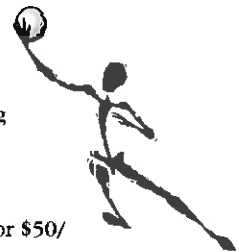

The Lancaster County (PA) Post Card Club will provide a look at our past with a large retrospective display of people, places, and happenings. These remarkable postcards can stimulate memories and even some questions. Jack Loose, resident historian, will be nearby at the "Ask Jack" chair to enhance memories with past information surrounding the events and activities of this area.

Expect to find a few costumed former residents strolling down Lancaster Township's memory lane as well. James Buchanan, or his niece, Harriet Lane, and notable sculptor, Blanche Nevin, plan to be there. Perhaps one would prefer a "drive" down memory lane. The Vagabonds and other car enthusiasts will be displaying antique cars on the lawn.

Traditional games like croquet, jump rope, jacks, and checkers will be available for competition and a friendly tug-of-war between fire companies is also planned. Don't forget to take part in one of the sack races!

At 2:00PM, the Historical Commission will present Certificates of Recognition to several Township homeowners who exemplify the spirit of historic preservation by their level of home maintenance and loving attention to their properties, which enhances community character.

Township Home Nominated for National Historic Register

A historic Lancaster Township house has been nominated for inclusion in the National Historic Register. Now owned by Margaret and Gerald S. Lestz, the handsome house, built in 1806 by Jacob Miller, has been kept in excellent condition by its appreciative owners. An architectural gem, tradition says it was designed by the noted Pennsylvania architect, Stephen Hill. Hill also designed the Montgomery House in the first block of South Queen Street and the original Capitol Building in Harrisburg. Three Wellford fireplace mantels are of special interest. In a discussion of the work of Robert Wellford, architectural historian Mark Reinberger wrote, "The Jacob Miller house was among the elite of Lancaster ..." The mantelpieces "were distinctly sophisticated for Lancaster ..."

Adjacent to the Miller house and along the Conestoga River are the ruins of an old fulling mill used for processing textiles until 1836. At that time it was converted into a water-powered pumping station for Lancaster's first municipal water supply. Waterwheel-operated pumps delivered water from the river uphill to a reservoir on East King Street (now Reservoir Park). City Mill, as it was known, served until the 1880s as the Lancaster pumping station.

Jacob Miller was an enterprising promoter of local industry. He built a cotton mill downstream near the South Duke Street crossing. This large four-story stone spinning and weaving mill was built in 1812. Financial reverses following the War of 1812 forced the closing of the mill. It was used for other manufacturing purposes until it burned in the 1870s.

The Jacob Miller House, under the loving care of Gerald and Margaret Lestz, remains a significant part of Lancaster's local architectural history and has been preserved as a warm, lovely home. Mr. Lestz is a popular writer and publisher of works on local culture and the arts. Mrs. Lestz is a well-known artist in the region with a show at the Demuth Museum in Lancaster through October 2. ■

NEW CONTRACT WITH CITY OF LANCASTER APPROVED

The Lancaster Township Board of Supervisors voted unanimously to extend the police services contract with the City of Lancaster for another year (2006) at a basic service fee of \$1,268,088. At the same time, the Board accepted a recommendation from the Public Safety Committee to eliminate the Township's dedicated sergeant position

on a one-year trial basis. It was emphasized that although the Township has had good experience with the three successive sergeants who have been assigned to the Township, it was felt that the officers are professional enough to continue doing a

thorough and conscientious job without the immediate oversight of a sergeant. Oversight of the officers will come from the City police station, as it was prior to having a dedicated sergeant at the Township.



Holiday Safety Tips

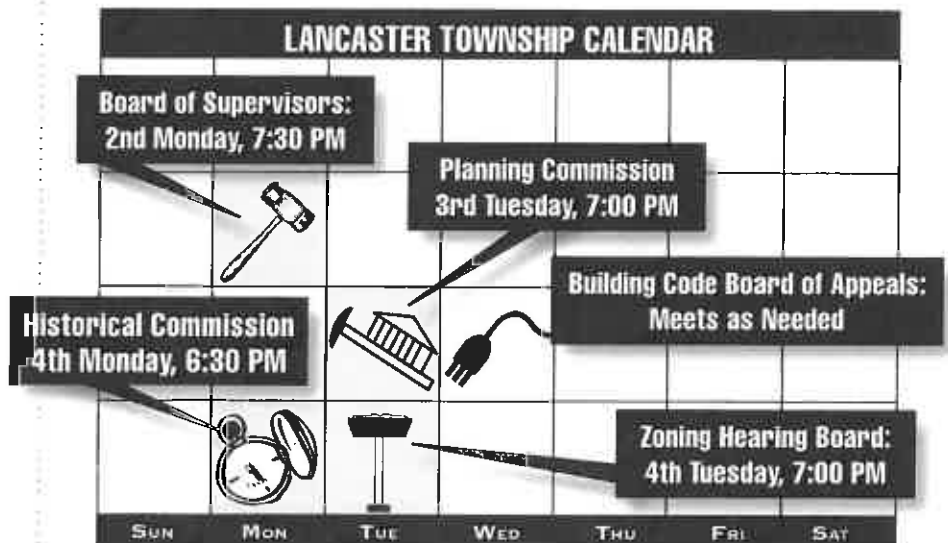
