UPDATE: TREE NOTICE – TOWNSHIP TREE TRIMMING BEGINS JUNE 20, 2019.

YOU MAY BE BILLED FOR REMOVAL OF TREES AND PLANTS IN THE RIGHT OF WAY.

April 18, 2019

Dear Resident,

Lancaster Township has a continuous road maintenance plan for the upkeep of all township roads and alleys. It is important that our roads are properly maintained in order to avoid much more costly repairs or replacement due to neglect.

Your street or alley is included in the 2019 repaving schedule.

Paving takes place between July 1st and August 15th on the following:

Alley A – N. Broad Street to Ranck Avenue
Alley B – SR1002 (E. Orange Street) to Clark Street
Alley C – Alley B to SR1002 (E. Orange Street)
Alley F – Clark Street to Alley E
Nassau Road – Ranck Mill to SR1002 (E. Orange Street)
Jamaica Road – Riverside Avenue to Nassau Road
Riverside Avenue – Ranck Mill Road to Jamaica Road
Clark Street – Riverside Avenue to Parkside Avenue
Betz Road – City Mill Road to S. Conestoga Drive
Conestoga Woods Road – Conestoga Road to Conestoga Drive
Conestoga Road – Conestoga Drive to Conestoga Woods Road

All plantings, trees, shrubs and flowers must be removed from the public Right-of-Way **before June 1, 2019.**

Trees overhanging the public roads or alleys from your property must be elevated to a minimum of 14-1/2 feet above the road surface. **Any obstructions placed within the right-of-way must be removed prior to June 1, of 2019.**

If low hanging tree branches, plantings and or obstructions remain after June 1, they will be removed by the Township Public Works Department or our sub-contractors. You may be billed for removal of these items by the Township or our sub-contractor.

If you anticipate upgrades or changes to your water, sewer, electrical or gas service, or if you are planning driveway resurfacing, etc., you should arrange to **have all of these completed before July 1, 2019.**

All utilities have been notified of the township paving plan for 2019.

During the actual paving days you will experience some inconvenience:

- **No Parking on street or alley during the days of milling or paving**
- **Street and Alley closed for several hours on paving days**

You will be notified of specific paving days for your road at least 48 hours in advance.
