A. SWM 20-0035 – Buchanan Elementary – Stormwater Management Site Plan Waiver Request

The board will act on a request for a stormwater management site plan waiver of the Lancaster Township Stormwater Management Ordinance (2014) Section 229-36 – Major Land Disturbance, for SWM 20-0035, Buchanan Elementary, and conditioned upon township engineer Ben Webber's March 9, 2020, review letter. - B. LTPC 276 City of Lancaster Groff's Run Daylighting/Restoration Stormwater Management Site Plan Waiver Request
 The board will act on a request for a stormwater management site plan waiver of the Lancaster Township Stormwater Management Ordinance (2014) Article IV for LTPC 276, the City of Lancaster Groff's Run Daylighting/Restoration, and conditioned upon township engineer Ben Webber's March 9, 2020, review letter.
